

BICKNELL TOWN ORDINANCE NO. 1992-2

AN ORDINANCE LIMITING CONNECTIONS TO THE  
CULINARY WATER SYSTEM FOR USE AND DEVELOPMENT  
WITHIN PRIME AND UNIQUE FARM LAND AREAS.

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF BICKNELL  
TOWN, WAYNE COUNTY, STATE OF UTAH:

WHEREAS, the Farmers Home Administration has required as a condition of its purchase of the \$55,300 Subordinated Water Revenue Bond, Series 1992, the proceeds of which are to be used to construct and improve the culinary water system of Bicknell Town (the "Town") that the Town limit the types of connections to the culinary water system for improvements in areas designated as prime and unique farm lands; and

WHEREAS, it is in the best interest of the citizenry of Bicknell Town and the surrounding area to take reasonable steps to maintain and preserve areas designated as prime and unique farm land or agricultural property;

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

SECTION 1: PREAMBLE INCORPORATED. The entire preamble is incorporated into and is a part of the ordinance.

SECTION 2: RESTRICTIONS ON CONNECTIONS TO CULINARY WATER SYSTEM. Connections to the Town culinary water system for use and development within areas designated as prime and unique farm land shall be limited to single residential connections.

SECTION 3: PRIME AND UNIQUE FARM LAND DEFINED. Prime and unique farm land shall mean such areas as determined from time to time by the United States Soil Conservation Service of the Department of Agriculture.

SECTION 4: EFFECTIVE DATE AND POSTING ORDINANCE. The ordinance shall take effect immediately following its adoption and the posting thereof in the following three (3) public and conspicuous places in Bicknell Town:

- (1) Bicknell Town Hall;
- (2) U.S. Post Office, Bicknell, Utah; and
- (3) Bicknell Town Bulletin Board.

PASSED, APPROVED AND ADOPTED by the Mayor and Town Council of Bicknell Town, this 2nd day of December, 1992.


